S&P Global Ratings upgrades IREDA's Long-Term International Credit Rating to 'BBB' with 'Stable' Outlook

IREDA on October 28, 2025, received an upgrade in its long-term issuer credit rating from S&P Global Ratings, moving to 'BBB' from 'BBB-', with 'Stable' Outlook. The short-term rating also revised to 'A-2' from 'A-3'.

This upgrade brings IREDA's international credit rating in line with India's sovereign credit rating, underscoring the company's strategic importance to the nation's renewable energy mission.

S&P Global Ratings considered IREDA's robust asset quality, sound capitalisation and strong liquidity profile as key factors behind the upgrade. The rating enhancement is expected to strengthen IREDA's funding capabilities, reduce its cost of capital and further enhance investor confidence across both equity and debt capital markets, reinforcing its leadership as India's premier green financing institution.

Commenting on the development, Shri Pradip Kumar Das, CMD, IREDA, said: "We are delighted with this upgrade by S&P Global Ratings, which not only validates IREDA's financial strength but also highlights our critical role in India's renewable energy transition. This alignment with the sovereign rating will enable us to access capital more competitively and deepen investor confidence in our long-term strategy."

Q2 Results: IREDA posts 41% Rise in Net Profit, 81% Growth in Loan Disbursements



IREDA on October 14, 2025 announced its audited financial results for the quarter and half year ended September 30, 2025, continuing its trajectory of robust growth and operational excellence.

The Board of Directors in its meeting held on October 14, 2025, at IREDA's registered office, approved the audited financial results. IREDA has registered significant year-on-year growth across key financial metrics. The company's expanding loan book, rising net worth and consistent profitability underscore its strategic focus and commitment to supporting India's renewable energy ambitions.

CMD, IREDA urges focus on Community-Driven Clean Energy to sustain India's Renewable Momentum



Shri Pradip Kumar Das, CMD, IREDA participated as a panelist in the session *"From Policy to Power: How Decentralisation is Putting Change in People's Hands"* at the Taj Palace, New Delhi, during the *"Sustainable is Attainable Fest 2025"* on October 14, 2025.

Highlighting India's renewable momentum, Shri Das noted that India's renewable capacity has reached 247 GW as of September 2025, with ~27 GW added in the first half of FY26, compared to 29.6 GW in all of FY25—a record pace of growth. To meet the 485 GW target by 2030, annual additions must rise to 50–60 GW, he said.

Shri Das emphasised that *renewables—solar, wind, hydro and bioenergy—are not just power sources but solutions for sustainability. Every unit of clean energy avoids nearly 750 grams of carbon, preserving our environment for generations.*

Speaking on IREDA's role, he stated that the future of clean energy lies not only in large solar parks but in millions of decentralised systems owned by farmers, cooperatives, MSMEs and housing societies — citizens who are both producers and consumers, or 'prosumers', of energy."

He added that IREDA's Retail Business Division, through its financing of decentralised projects under PM-KUSUM and Rooftop Solar, has demonstrated that green lending at the grassroots is viable and impactful.

He further noted that India's financial ecosystem—spanning cooperative, rural and commercial banks—has now matured, with mainstream institutions increasingly confident to participate in renewable and retail clean-energy financing.

Reaffirming IREDA's leadership, Shri Das concluded, *"With 38 years of experience, strong governance and a record of responsible growth, IREDA continues to lead India's energy transition — from large-scale renewables to empowering citizens through community-driven, sustainable energy solutions."*



MoS Shri Shripad Naik inaugurates IREDA's 45 kW Solar CSR Project for Goa Water Supply

Shri Shripad Naik, Hon'ble Union Minister of State for Power and New & Renewable Energy on October 4, 2025, inaugurated the installation of a 45 kW On-Grid Solar Power System at a water pumping station in North Goa district under IREDA's CSR initiative.

Expected to generate about 60,000 units annually, the project will achieve 100% solarisation of the pumping load. It aims to showcase how renewable energy can sustainably power public water distribution systems.

IREDA reinforces commitment to Renewable Energy Expansion in North-East: CMD

IREDA has reaffirmed its strong commitment to accelerating renewable energy (RE) growth in the North-Eastern Region (NER). Speaking at the event *“Financing Renewable Energy in the North Eastern Region”* in Guwahati on October 31, 2025, Shri Pradip Kumar Das, CMD, highlighted the region’s immense green energy potential and IREDA’s pivotal role in driving inclusive, sustainable development.

Shri Das noted that India’s RE capacity has tripled since FY14 and is set to double again by FY2030, requiring an additional ₹28 lakh cr. in investments.

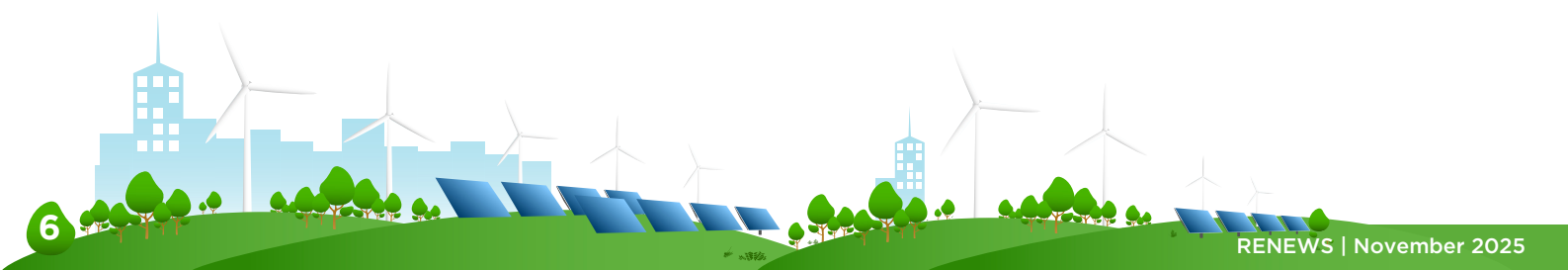
With a vast RE potential, driven by Hydropower and Solar energy—the North-East stands poised to play a key role in India’s clean energy future. The North-East region has achieved significant progress in clean energy, with approximately 5 GW of renewable capacity — accounting for nearly 60% of its total installed power generation capacity. IREDA has already sanctioned over ₹3,500 cr. in financing to the region, offering concessional interest rates for RE projects, including a 50 basis points rebate for projects in the North-East and 50 basis points rebate for women-led projects. Under flagship schemes like PM-KUSUM and Rooftop Solar, IREDA has supported thousands of solar installations, including 3,800 solar pumps in Tripura and several rooftop projects across Assam.

Shri Das emphasised that with strengthened grid connectivity, targeted reforms, and innovative financing, the North-East can emerge as a green energy hub for India and beyond. “The North-East is our green frontier, IREDA is committed to empowering the region with clean, affordable and reliable renewable energy”, he emphasised.

As a matter of fact, the majority of business vertical heads in IREDA as on date are from the Northeast, enabling a deeper understanding of local opportunities and challenges in renewable energy development.

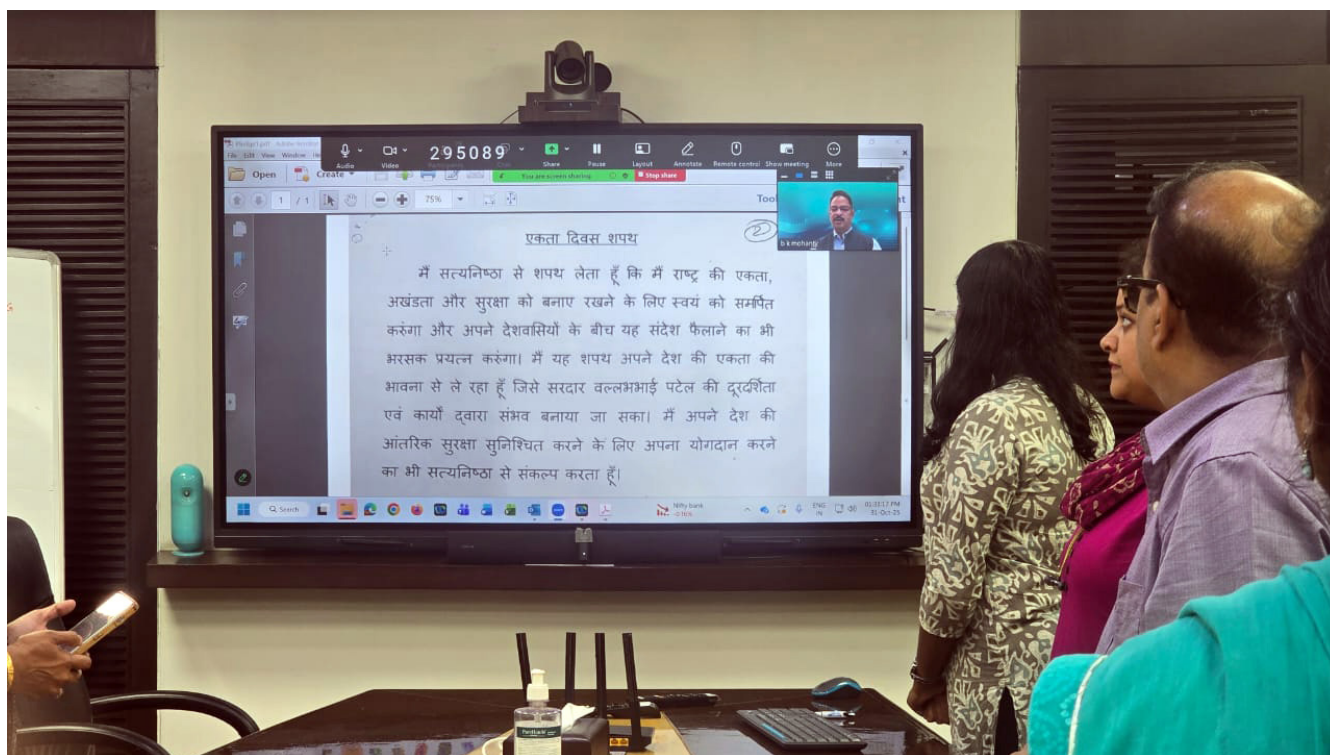
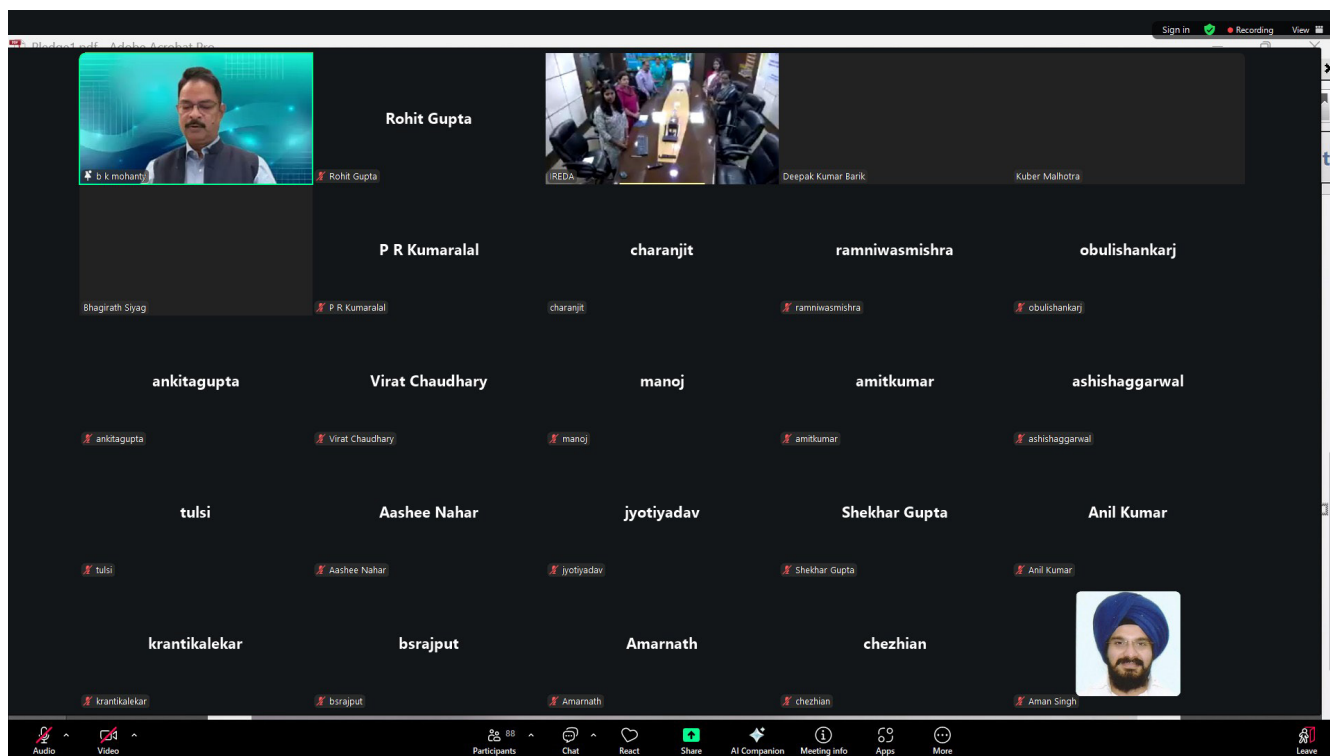

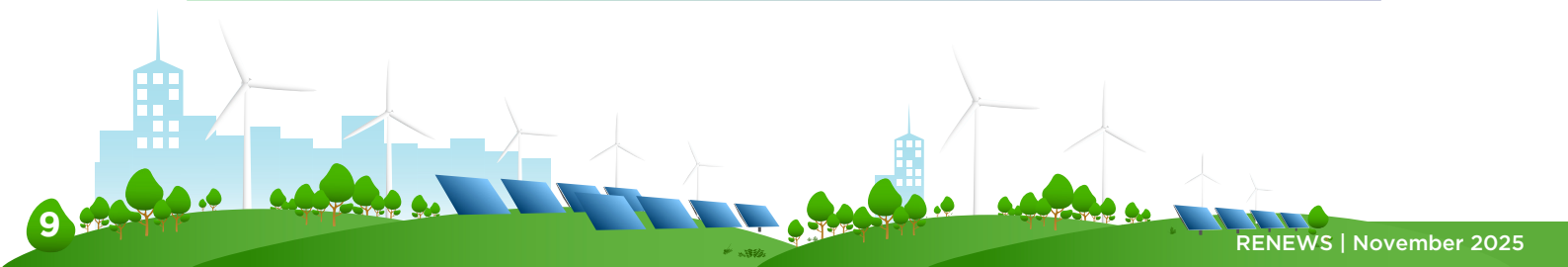

While disbursements were 81% higher at ₹8,062 crore from ₹4,462 crore in the quarter ended 30 September 2025. As of September, the company's net worth was ₹12,920 crore, up 38% over ₹9,336 crore a year ago. The article is attributed to PTI.
